THE PRESET OF EQUIPMENT, AND AN **8 HOUR EVENT WORK DAY** ONLY. ASSISTANT TO TCM AND FLAGGING HOURS ARE BASED ON 1 ASSISTANT WORKING 10 HRS (2 DA YS) AND **9** FLAGGERS WORKING 8 HOURS (1 DAY). PILOT CAR HOURS ARE BASED ON 1 PILOT CAR DRIVER WORKING 8 HOURS/1 DAY IF NEEDED.



4. CONTRACTOR MUST GIVE THE CC DISPATCH DEPARTMENT VERBAL NOTIFICATION FOR THE CANCELLATION OF A SCHEDULED WORK DAY **72 HOURS** IN ADVANCE OR ADDITIONAL CHARGES SHALL BE BILLED.
5. ACTUAL EQUIPMENT QUANTITIES, DAYS OF RENTAL, AND DAYS WORKED WILL BE BILLED.
6. CONTRACTOR SHALL SCHEDULE EVENT VERBALLY WITH CC DISPATCH DEPARTMENT A **MINIMUM 3 WEEKS IN ADVANCE AND AGAIN CONFIRM SCHEDULING 72 HOURS IN ADVANCE.**

1. CONTRACTOR AGREES TO PAY CC ENTERPRISES WITHIN THIRTY (30) DAYS FROM DATE OF INVOICE.

INTEREST WILL ACCRUE AT RATE OF FIFTEEN (15) PERCENT PER ANNUM ON PAYMENTS NOT MADE IN A TIMELY MANNER. IF IT BECOMES NECESSARY FOR CC ENTERPRISES TO INCUR COLLECTION COSTS FOR ANY AMOUNT DUE UNDER THIS AGREEMENT, THE UNDERSIGNED PROMISES TO PAY ADDITIONAL COLLECTION COSTS INCLUDING REASONABLE ATTORNEY FEES AND COURT COSTS.
