APPROVAL OF THIS APPLICATION IS CONTINGENT UPON MUTUAL ENDORSEMENT OF THE FOLLOWING TERMS:

THE APPLICANT ORGANIZATION SHALL:

- (1) Provide suitable space for the vehicle(s) which will allow easy and direct access to the scene of the event.
- (2) Hold the District not liable for loss or damage including the claims, costs, demands, or Judgments made against the APPLICANT ORGANIZATION as a result of the District's failure to provide adequate services as requested by the APPLICANT, should (a) the FIRE CHIEF require the vehicles to answer an EMERGENCY CALL, or (b) circumstances beyond the control of the DISTRICT render the DISTRICT unable to provide the vehicles requested.
- (3) Allow the FIRE CHIEF to determine at his sole discretion where the equipment and crew shall be stationed and how they are to be dispatched.

THE DISTRICT SHALL:

- (1) Make all reasonable efforts to provide vehicles and crews within the requirements set out in the application.
- (2) Reserve the right to determine whether any fee should be refunded because of the special event(s) being canceled, discontinued, or otherwise delayed in part or in whole.
