The Permit Number listed above is about to expire on 09 Sep 2024. It is the legal responsibility of the Applicant and Property Owner to complete all work and have all required inspections completed and approved prior to the permit expiration date listed above. Please review the three options listed below to ensure your permit and property remain in compliance with our adopted codes.

Option 1: If all work has been completed, then more than likely you're receiving this letter because you did not schedule and complete a Final Inspection for this permit. Please call our office at 970-870-5566 to schedule the final inspection or schedule online through the CityView Portal, so we can ensure the work was completed properly and then close out your permit and provide you a certificate of completion or occupancy prior to the expiration date of this permit.

Option 2: If you need more time to complete the scope of work under this Permit Application, the Building Department can review your request and consider providing a Permit Renewal to extend your permit for one additional year beyond your expiration date so you can complete all remaining work. We have a Permit Renewal Fee that typically costs \$46.15 to extend your permit, but this must be reviewed based on what work is left to complete. Please contact our office at 970-870-5566 if you want to request a permit renewal and extension.

Option 3: Please contact us directly if neither option above will work and you are unable to complete the scope of work under the Permit Application due to unforeseen reasons. We will take the time to review your project, work completed to date, and inspections we have completed to date, to see if other options are possible to close out the permit and cancel portions of the work left uncompleted that do not pose a serious life safety concern for the property and building.
