The above referenced application appears satisfactory with the following exceptions:

RCRBD Routt County Regional Building Department requires the architect not only to provide a code analysis on all commercial projects but to include the results of how the project measures up. Please have Architect verify each item in the attached analysis is met. For example, the plan indicates a certain type of stair commonly referred to as a "winder". Winders are only permitted in single family dwellings and must be constructed to certain specifications but not limited to handrail (sole purpose of this permit).

Additional inspection items were found Friday, August 5th at 1:00 when Ben Grush, Building Official and I met Doug Shaffer, Jason Lacey and the Larson's at their barn to have a site visit regarding Permit/Application: TB-16-188 at 32130 WILD GOOSE LN, STEAMBOAT SPRINGS (Note: this is a duplicate permit with incorrect address, auther recommends setting to inactive to reduce confusion).
