Todd,

Apologies for the lack of response. I do not believe you are restricted to the high pressure line. You would need to look at the final plat notes. There are two lots north of you that are restricted on the plat. They cannot be served by the current water main. You would need to apply for your building permit and pay tap fees for the new water service. The lots in Fox Grove Subdivision are above the serviceable elevation of the line that you are currently fed by, and that is why they were required to install the water main for the high pressure line.

I have a question regarding water connections on Huckleberry Lane. I live at 100 Huckleberry Lane, which is in the County, but on City water and sewer. I am in the process of subdividing my lot with the county so I can build a small house on the new lot. I do not have an assigned address, but it is part of our lot at 100 Huckleberry Lane. Alan Goldich mentioned that I should gain clarity from City staff about connecting to the old water line vs. the new HP line. He specifically mentioned that we may not be able to connect to the old line. Is this correct? I know that the development behind us (Fox Grove) was required to tie into the new HP line. Would this be the case if we were to eventually build and need to tie into City water? As a point of clarity, this would not be a secondary unit, but a completely separate house on a separate lot than our existing home. Can you provide any clarity on this?
