Walter,

I discussed your request with FEMA. They said that this is an acceptable path moving forward. Is there any reason that you requested an extension to 2025? As you stated, it would be best to do the modeling after all excavation is completed. I believe it would be more appropriate to request that this study be completed before final reclamation starts, not a specific date. Please revise your request with this timeframe.

A Floodplain Development permit still needs to be obtained so that this request can be incorporated into a condition of approval requiring that this study be done prior to closing out the permit. The floodplain permit costs \$112. We have all of the documentation that is needed for this permit at this time so the application fee is all that needs to be submitted. This is to cover the administrative costs of reviewing this request and processing the application. The SUP will also need to be modified to reflect this change as well. This will most likely result in a similar condition being placed in the SUP requiring this study to be completed prior to closing out the permit. There will be no cost for the SUP amendment since it will clarify the existing condition of approval.
