Tim,

This is a great general description of noxious weed management and the noxious weed act, but we really need more site specific information and specific mitigation measures for it to truly be a weed management plan.

It would be greatly appreciated, if you would please respond to the following questions:

- 1. What are the management goals of the HOA? (Is to maintain native vegetation? Maintain wildlife habitat? Etc.)
- 2. I see "The HOA shall map noxious weed infestations within Tailwaters, with the goal of finding new infestations, monitoring control of noxious weeds, and to meet the requirements of the Colorado Noxious Weed Act."
 Do you currently have any data of the specific noxious weed species currently found on the
 - site? Ideally we would be provided with spatial data and maps of inventoried weeds on the site but at the minimum an inventory of specific species. To have detailed management plans and effective timing windows, we need to know the specific species we are targeting.
- 3. Do you have a specific management plan for managing noxious weeds before soil disturbance in order to reduce spread?
- 4. Do you intend to bring top soil onto the site or move top soil off of the site? Do you have mitigation plans for either of these scenarios?
- 5. Could you please add a similar line to the County list on Appendix A as you have on Appendix B "Note: The County may change their designated list after this plan is adopted. The most current list is the one that applies."
 - We are in the process of getting a new weed management plan and County noxious weed list approved so this list will be significantly different in the coming months.
