Chairman Robert McKune called the meeting to order with Commissioner Boggs present. Commissioner Hockett was absent. Carolyn Gras recorded minutes.

Barbara (Vance) Jones was elected to the Personnel Policies Board by votes tallied by Hazel White and the Commissioners.

EN RE: RESOLUTIONS

Upper Yampa Water Conservancy District/Special Use Permit James Funk/Special Use Permit H-G Coal/Subdivision Exemption Michael Ursich/Zone Change

K.F.M.U. Radio/Cher Mi Communications Corporation/Conditional Use Permit

EN RE: DESMUKE AND DISMUKE/RADIO LEASE

Upon recommendation of the Communications Committee, it was agreed to permit Dismuke & Dismuke to temporarily occupy space at the radio transmitter building at Mt. Werner until July 31, prorating the \$40/month fee from the date of occupancy. The committee, which said they would review a permanent lease at the end of July, was unwilling to make a long-term committment for the space until more definate plans for the county-wide communications system were known.

EN RE: SOUTHLAND ROYALITY COMPANY/SPECIAL USE PERMIT

Bob Miller and another respresentative from the Southland Royality Company, Denver Branch, David Yamada and John Hess reviewed a Special Use Permit petition for an Oil Mell covering 820 acres, located N₂ Section 22, Township 5 North, Range 88 West (The Temple Ranch). Miller explained that Peabody Coal Company had been contacted and an agreement had been reached. Commissioner McKune maintained that the bond should be held against any road damages done by the contractor in the amount of \$25,000. Commissioner Boggs moved to approve the Special Use Permit contingent upon:

EN RE: GARY PETRIE/ZONE CHANGE

Gary Petrie, David Yamada and John Hess reviewed the proposed zone change from Agricultural/Forestry to Commercial located at S½ Secion 1, Township 6 North, Range 85 West, West of Snow Bowl II & F.S.C. Electric. David Yamada stated that Gary Petrie had illegally divided the land and that the County could take legal action against him. Commissioner McKune made a motion for the zone change. Commissioner Boggs objected to the motion until a sketch plan is presented to the Planning Department; Commissioner McKune agreed, tabling the Item until a sketch plan is submitted.

EN RE: YAMPA VALLEY ELECTRIC ASSOCIATION/CONDITIONAL USE PERMIT

Ev Bristol, David Yamada and John Hess presented a petition for a Conditional Use Permit to install a transformer in the Clark/Hahns Peak area located at Tract 95, Section 28, Township 9 North, Range 85 West, to improve existing conditions and supply electric utilities for any expansion of Steamboat Lake. Commissioner Boggs moved that the Conditional Use Permit be granted if the set back requirements were filled. It passed unanimously after seconding by Commissioner McKune.

EN RE K.F.M.U. RADIO/CONDITIONAL USE PERMIT

David Yamada and John Mess reviewed the petition for a Conditional Use Permit for K.F.M.U. Radio. The Roard unanimously approved the permit with no special conditions.
