Dear Mr. Liman:

On May 20, 2009, an inspector from the Colorado Division of Public Health and the Environment, Hazardous Materials and Waste Management Division, Solid Waste and Materials Management Unit conducted an inspection of the Milner Landfill at Routt County Road 205 in Milner, Routt County, Colorado. This was a routine unannounced inspection conducted by the Department to determine the property's compliance status relative to the Solid Waste Disposal Sites and Facilities Act, Title 30, Article 20, Part 1 of the Colorado Revised Statutes ("the Act") and the Regulations Pertaining to Solid Waste Sites and Facilities, 6 CCR 1007-2, Part 1 ("the Regulations") and the approved Design and Operations Plan for the facility. A Compliance Advisory was issued to Twin Landfill Corporation on July 9, 2009 providing information regarding the violations and a time frame for correction of the violations.

Based upon your response and an additional inspection conducted on September 16, 2011 the Division believes that all of the issues identified in the Compliance Advisory have been adequately addressed. A copy of the inspection report is attached for your review. Therefore, the Division is hereby closing the Compliance Advisory and we intend to take no further action at this time.

If the violations cited in the Compliance Advisory occur in the future, the Division may issue a subsequent Compliance Advisory and/or Compliance Order. A copy of this No Further Action letter will be attached to the Compliance Advisory in the facility's file at our office.
