Additionally, your Waste Tire Facility has been assigned the Facility Decal Number listed below. The decal is valid until the expiration date also listed below, at which time, your facility must renew its registration in accordance with Section 10 of the Colorado Solid Waste Regulations (6 CCR 1007-2, Part 1).

Any change in location would require a new Waste Tire Certificate of Registration Application (Form WT-1) to be filed, as Certificate of Registration Numbers are location specific. Failure to have a Waste Tire Certificate of Registration Number for a new location or use of the wrong Waste Tire Certificate of Registration Number for shipment of waste tires may result in enforcement action under §30-20-1401, et seq, of the Colorado Revised Statutes (C.R.S.), and Section 10 of the Colorado Solid Waste Regulations (6 CCR 1007-2, Part 1). Also, in accordance with Section 10 of the regulations, if any of the following changes occur, this office must be notified in writing at the above address: 1) mailing address, 2) business name, 3) type of registration, 4) contact name or phone number, 5) ownership, or 6) the site has closed.

Please be aware that the handling and management of waste tires, including the generation, collection, transportation, processing, storage, and disposal of waste tires, is regulated under Section 10 of the Colorado Solid Waste Regulations (6 CCR 1007-2, Part 1). #### **Special Provisions for Waste Tire Haulers**

A copy of this Certificate of Registration must be retained at your facility. If you are a Waste Tire Hauler the assigned vehicle decal numbers and their expiration dates are listed below.


If you requested contracted commercial/freight carrier decals, the assigned temporary decal numbers are listed below. A copy of this Certificate of Registration must be retained in EACH vehicle temporarily contracted to haul waste tires. The Temporary Waste Tire Hauler Decal must be displayed on the lower left hand side of the windshield, or in some other manner so the decal is visible on a vehicle that does not have a windshield.

#### **Special Provisions for Mobile Waste Tire Processors**


A copy of this Certificate must be maintained at the permanent address of your facility and made available for inspection. The Mobile Waste Tire Processor decal must be affixed to the mobile processing equipment. If the decal cannot be affixed to the mobile processing equipment, the decal must be made available for inspection. Your Mobile Waste Tire Processor decal number and expiration date is listed below.



## Requirements for Waste Tire Generators reviewed/revised February 2020

Waste Tire Generators are persons that generate motor vehicle or trailer waste tires. This includes, but is not limited to, new tire retailers, used tire retailers, automobile dealers, automobile dismantlers and scrap yards, vehicle maintenance shops, garages, service stations, car care centers, fleet operators and wholesalers that are sources of motor vehicle and trailer waste tires. Waste tire generators must be in compliance with Section 10 of the Regulations Pertaining to Solid Waste Sites and Facilities, 6 CCR 1007-2. This document summarizes the main requirements for a Waste Tire Generator regarding registration, decals, storage limits, shipment of waste tires, manifests and other generator requirements.

### What is a Waste Tire?

A waste tire is a tire that is modified from its original specifications but has not been processed into a tire-derived product. It is no longer being used for its initial intended purpose as a tire and cannot or will not be resold as a used tire.

Waste tires come from a variety of vehicles such as passenger cars and trucks, motorcycles and motor scooters licensed to travel on roads, semi trucks and semi trailers, any trailer towed behind a car, motor homes, mini vans, campers, buses and medium-duty trucks.

### Registration and Decals

- You must register with us as a Waste Tire Generator prior to commercially generating waste tires.
  - The Waste Tire Certificate of Registration Application form (Form WT-1) is available on our website using the "Forms and applications" link at [www.colorado.gov/cdphe/wastetires](http://www.colorado.gov/cdphe/wastetires).
- Once registered, you will receive a Waste Tire Certificate of Registration and a Waste Tire Facility decal from us.
  - You must maintain a copy of your Waste Tire Certificate of Registration at your facility and make it available for inspection. The Waste Tire Facility decal will have a unique number and must be displayed in a prominent location at your facility that is visible to your waste tire hauler.
- The Waste Tire Facility Certificate of Registration and decal do not expire. This is a onetime registration per location.
  - The Certificate of Registration is non-transferable and cannot be used at another location or by another person or entity.
  - If you will be generating waste tires at a new location not previously registered with us, you must submit a separate Waste Tire Certificate of Registration Application for the new location.
- You are required to notify us (using Form WT-1) whenever changes occur to the following: ownership, mailing address, business name, type of registration, contact name, and/or phone number. You are required to notify us in writing or by email if you are no longer generating waste tires at the location registered with us.

### Storage Limits

- You may store up to one thousand five hundred (1,500) waste tires at your facility at any one time.
  - Of these one thousand five hundred (1,500) waste tires, up to five hundred (500) waste tires can be stored outside.
- If these storage limits are exceeded, you must meet the requirements for Waste Tire Collection Facilities in Section 10.8 of the solid waste regulations. If you store more than one hundred (100) waste tires, you must have security measures, such as fencing or security cameras, in place to prevent unlawful access to the waste tires.
- You must store waste tires in a way that does not create nuisance conditions that could attract disease-carrying animals or insects.



## Disposition of Waste Tires and Manifests

- You must arrange for the commercial hauling or mobile processing of your waste tires only with a Waste Tire Hauler or Mobile Waste Tire Processor that is currently registered with us.
  - You must receive a properly completed Uniform Waste Tire Manifest (Form WT-2) from the hauler within thirty (30) days of delivery of each load of your waste tires to the destination facility.
  - You must receive a properly completed Uniform Mobile Waste Tire Processor Manifest (Form WT-7) from the processor at the conclusion of mobile processing at your facility.
- If you self-haul nine (9) or less waste tires at a time to a waste tire destination facility (e.g., another waste tire generator, waste tire processor, waste tire monofill and/or approved beneficial user of whole waste tires), you must document where the waste tires were delivered. You must keep records for three (3) years from the date the waste tires were delivered to the waste tire destination facility. Form WT-10 satisfies the documentation requirement.
- You may accept ten (10) or more un-manifested waste tires or ten (10) or more waste tires from an unregistered waste tire hauler **only** if you complete and submit a Uniform Waste Tire Manifest (Form WT-2) to us within twenty (20) days from the end of the preceding month.
  - The manifest must include the date(s) waste tires were accepted, the total amount of waste tires accepted, the license plate number of the vehicle used to deliver the waste tires and if available, the name, address, and telephone number of the person who delivered the waste tires and the source of the tires.
- You must keep the completed manifests on site at your facility for three (3) years from the date the tires were accepted or picked up. Manifests must be made available for inspection.

## Other Requirements

- You must immediately notify us in the event of a fire or other emergency involving waste tires. Reporting this event or emergency to our Environmental Release and Incident Reporting Hotline at 1-877-518-5608 satisfies this reporting requirement.
  - Within two (2) weeks of notification, you must submit a written report detailing the emergency, including a description of the origin of the emergency, actions taken, planned actions, results or anticipated results of your actions and an approximate date of resolution of the problems generated by the emergency.
- You must comply with applicable local fire codes or with the fire code currently adopted by the Colorado Division of Fire, Prevention and Control in the Department of Public Safety in the absence of adequate local fire codes.
- You must maintain a working telephone at your facility.
- You must maintain all-weather access roads to those areas of your facility where waste tires are stored.
- You must collect litter in and around any area at your facility used to store waste tires to avoid fire hazards or nuisance conditions, and control vegetative growth to minimize potential fuel sources.
- You may be required to furnish additional information concerning your compliance with the regulatory requirements using a self-certification process. If so, you will be notified when and how to complete the self-certification checklist.
- You must collect a \$1.25 fee on the sale of each new automobile, trailer, truck, motor home or motorcycle tire that you sell. Please refer to the Waste Tire Fee Bulletin on our website for additional information.
