Proposal:	This is a Minor Amendment to an existing PUD.
	Rocky Mountain Sled Rentals (RMSR), a concessionaire of Steamboat Lake State Park, would like to move their seasonal snowmobile rental business to a portion of State of Colorado land, Board of Land Commissioners (SLB) property, known as the Qualley Cabin, which is managed by Steamboat Lake State Park. This has already been approved by Steamboat Lake State Park and the SLB.
	RMSR operates out of approximately 6 snowmobile trailers and one temporary steel building. It's operating season is Dec to April with a goal of having all trailers and the temporary building removed from the property prior to Memorial Day weekend. Sanitary facilities would be supplied and maintained by RMSR. Snow removal would be the responsibility of RMSR also. The area will be gated and signed stating it is only to be used for the rental business and not the general public. Every effort will be

	made by RMSR to minimize the impact to this area.
	Steamboat Lake State Park also intends to seek out grants to repair the cabin so that it can be used as a classroom for outdoor related education.
	The entrance to the property from CR 129 would need to be widened. The existing culvert will accommodate the widening work. A double gate would also be installed. The power would be supplied by a generator this season. There is already power to the cabin and permanent power hookups may be installed next summer for RMSR. The cabin's old parking area may be improved to accommodate future use. All major ground disturbance will go through the appropriate review processes to limit environmental impact.
